- August barbecue net income of £666.64, which is a significant increase on the 2014/15 figure of £560.34.
- Due to timing of billing, electricity cost showed a net debit of £259.18.
- Again due to timing of billing, the Water and Sewerage cost of £158.97 was significantly lower than 2014/15 costs of £264.81.
- Regular cleaning costs, including materials were £340.57.
- Maintenance cost totalled £41.86.
- End of year balance increased by £1,435.18 to £10,126.49.
- An excellent year of quiz income saw a total of £916.01 raised.
