	a. <i>Neighbourhood Plan (NP)</i> – the NP Steering Group had selected Mrs McCann as their Regulation 17 Inspector. The Clerk had advised Ms Emma Ball, CC of this decision.	Information

	b. Planning Applications –	
	i. <u>PA20/02628, Wycherley, 16 Meadow Close, Polruan</u> – proposed new dwelling. <b>NO OBJECTION</b> , but Members would prefer a slate pitched roof, rather than the flat roof proposed.	Clerk
	ii. <u>PA20/01027, Land Adjacent to Hall Farm, Old Road, Bodinnick</u> – temporary agricultural dwelling. Members were asked to reconsider their response to this application, following clarification that this dwelling is for his personal use (Agricultural Appraisal refers).	
	NOTE – the agent, Mr Mark Dyson, had asked for an extension to the planning deadline, which would allow him to submit new plans. He had suggested that the type of temporary dwelling is changed to a low-profile timber clad structure (with much the same appear- ance and profile as a field shelter) possibly screened with a more substantial earth and turf bank, however, this had not been done.	
	All Members wished to support this local farming business and Cllrs. Talling and Bunt proposed support for the application. Cllr. Talling said it met Theme 1 objective 1 of the main Cornwall plan. He emphasised the costs involved in running such a business.	

	Cllrs. Adams, Fisher and Carter objected to the proposal as it stands. Cllr. Fisher said he would rather the application was with- drawn and a new application submitted, giving weight to Para. 79 (e) of NPPF, Policy 7 (5) of CLP and policy 1 of the emerging NDP. Cllrs. Moore and T Libby spoke of the need to support local businesses and this agricultural enterprise which, from both reports, looks to be sound. However, they felt this temporary dwelling should be regarded as an annexe to the farming business at Hall. They agreed with Mr Jim Wood of Cornwall AONB, who had objected to this application, saying: "In order to avoid unacceptable effects on the designated landscape it should be located in a more discrete location within the pattern of existing agricultural buildings either to the north or south in order to avoid it being an isolated and discordant element with the landscape." The Clerk to submit these comments to Mr Jonathan Luker, Planning Officer, and maintain Members' objection to the application.	Clerk

	a. <i>Highway Walkabout</i> – representatives from the PC met with Mr Paul Allen and County Cllr. Hannaford on 13 <sup>th</sup> March to look at a number of issues:	
	i. <u>Uneven Road</u> – by the Garden House, St Saviour's Hill and Top of Trethake. The road at Battery Lane was being undermined by roots from the large fir tree. Mr Allen thought they may just overlay with tarmac to level out.	
	ii. <u>Blocked Drains</u> – drains at Mixtow, Butts Park, Top of Trethake and Tredudwell. Although the cyclical gang had dug out quite a few gullies some had not been done. The drain at Essa seemed blocked so water was bubbling up in the drain from the other side of the road and running over the top of the drain down into the field rather than under. It is hoped the gullies at Butts Park will be cleared of silt as a stop gap until the farmer landowner can be asked to allow a longer soak away in the field.	
	iii. <u>Pont Bottom</u> – the leat wall has broken through and the water is leaking out into the road. There were a few potholes on this section as well but filled with water.	
	iv. <u>Residents' Parking Signs, Bodinnick</u> – Cllr. Hannaford will request replacements as the green wall signs are not that visible.	
	v. <u>Chapel Flats</u> – the bottom one had been gutted and they said the top flat is a lot further along.	
	vi. <u>Road Signs at Butts park</u> – were very battered and rusted through. Mr Allen will order replacements.
