He explained that he felt that this is a useful event to engage with locals and that they will try and attend meetings quarterly. Cllr Candy reported that The Saltash Tunnel works are still ongoing, with works at Stoketon Cross, just this side of Saltash on A38, about to start and that he is on the Tamar Bridge and Ferry Joint Cttee, and Co -Chair of Mount Edgcumbe Joint Cttee. He reported that Nick Marsden has asked one of his team to liaise directly with Graham Palmer on behalf of Polruan Town Trust re the Winklepicker funding. Finally, the Ambulance Service, (SWAST) is trying to reduce costs by not funding the Co Responder Fire Service officers, some of whom operate from Polruan. Their plan is to replace them with volunteers, but they have a more limited role, for example cannot attend road accidents. | |
